**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PARTS OF SAI WOO LANE PLAYGROUND,
SECTIONS OF QUEEN'S ROAD WEST AND TSZ MI ALLEY; AND
TEMPORARY ALTERATION OF SECTIONS OF SAI WOO LANE AND
DES VOEUX ROAD WEST AS VEHICULAR ACCESS**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 9 March 2015 (the 'Order'), authorized:-

- (I) the temporary closure of parts of Sai Woo Lane Playground, as delineated and shown in yellow on the Plan numbered WIL/G05/0002/7;
- (II) the temporary partial closure of the section of Queen's Road West between its junction with Wilmer Street and a point about 25 metres east of its junction with Eastern Street, as delineated and shown in orange on the Plan numbered WIL/G05/0002/7;
- (III) the temporary closure of the section of Tsz Mi Alley adjacent to Sai Woo Lane Playground, and the section of Tsz Mi Alley between its junction with Queen's Road West and a point about 15 metres north of the junction, as delineated and shown in red and green respectively on the Plan numbered WIL/G05/0002/7; and
- (IV) the temporary alteration of sections of Sai Woo Lane and Des Voeux Road West as vehicular access, as delineated and shown in blue and pink respectively on the Plan numbered WIL/G05/0002/7,

during the period from 1 April to 30 June 2015 for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out, the areas of Sai Woo Lane Playground and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near Sai Woo Lane Playground and the roads affected by the Order on 13 March 2015.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure or alteration of the relevant part or parts of Sai Woo Lane Playground and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Sai Woo Lane Playground and the roads affected by the Order.

Notice is hereby given that further closure and/or alteration of the same part or parts of Sai Woo Lane Playground and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure and/or alteration will be published if and when such an order is made.
