**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF
THE OPEN SPACE IN HILL ROAD REST GARDEN AND
SECTIONS OF HILL ROAD AND SOUTH LANE
ADJACENT TO HILL ROAD REST GARDEN**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 30 June 2014 (the 'Order'), authorized:-

- (I) the temporary closure of the open space in Hill Road Rest Garden, as delineated and shown in yellow on the Plan numbered WIL/G03/0001/5;
- (II) the temporary partial closure of the section of Hill Road (including the staircase connecting Hill Road and South Lane) adjacent to Hill Road Rest Garden, as delineated and shown in green on the Plan numbered WIL/G03/0001/5; and
- (III) the temporary partial closure of the section of South Lane adjacent to Hill Road Rest Garden, as delineated and shown in blue on the Plan numbered WIL/G03/0001/5,

during the period from 24 July 2014 to 31 March 2015 for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out, the open space and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered WIL/G03/0001/5 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the open space and the roads affected by the Order on 4 July 2014.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open space and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open space and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open space and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
