**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF THE OPEN SPACES IN MUI FONG STREET
CHILDREN'S PLAYGROUND AND CENTRE STREET SITTING-OUT AREA,
PART OF THE OPEN SPACE IN KING GEORGE V MEMORIAL PARK,
HONG KONG, AND SECTIONS OF CENTRE STREET, EASTERN STREET,
HIGH STREET, FIRST STREET AND SECOND STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 14 July 2014 (the 'Order'), authorized: —

- (I) the temporary closure of the open space in Mui Fong Street Children's Playground, as delineated and shown in light blue on the Plan numbered WIL/G05/0008/4 during the period from 6 August 2014 to 30 January 2015;
- (II)
 - (a) the temporary closure of the open space in Centre Street Sitting-out Area, as delineated and shown in pink on the Plan numbered WIL/G05/0008/4;
 - (b) the temporary closure of part of the open space in King George V Memorial Park, Hong Kong, as delineated and shown in grey on the Plan numbered WIL/G05/0008/4;
 - (c) the temporary partial closure of the section of Centre Street between First Street and Second Street, the section of Eastern Street between High Street and Bonham Road, as delineated and shown in yellow and brown respectively on the Plan numbered WIL/G05/0008/4;
 - (d) the temporary partial closure of the section of High Street between its junction with Eastern Street and a point about 60 metres west of the junction and the section of High Street between a point about 75 metres west of its junction with Eastern Street and a point about 10 metres west of its junction with Centre Street, as delineated and shown in red on the Plan numbered WIL/G05/0008/4; and
 - (e) the temporary partial closure of the section of First Street between Centre Street and a point about 130 metres west of its junction with Centre Street, and the section of Second Street between Centre Street and a point about 130 metres west of its junction with Centre Street, as delineated and shown in green and orange respectively on the Plans numbered WIL/G05/0008/4 and WIL/G08/0008/3,

during the period from 6 August 2014 to 5 August 2015,

for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out, the areas of the open spaces and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered WIL/G05/0008/4 and WIL/G08/0008/3 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public: –

A copy of this notice will be affixed on or near the open spaces and the roads affected by the Order on 18 July 2014.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open spaces and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open spaces and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open spaces and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
