**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF CENTRE STREET SITTING-OUT AREA**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 14 June 2017 (the 'Order'), authorized the temporary closure of Centre Street Sitting-out Area, as delineated and shown in red on the Plan numbered WIL/G05/0008/7 during the period from 1 July 2017 to 31 March 2018 for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out, the area of Centre Street Sitting-out Area to be affected and the manner in which it will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Centre Street Sitting-out Area or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Centre Street Sitting-out Area affected by the Order.

Notice is hereby given that further closure of the same part or parts of Centre Street Sitting-out Area or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
