Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 14 July 2014 (the 'Order'), authorized the temporary closure of the open space in Sai Woo Lane Playground and the section of Tsz Mi Alley adjacent to Sai Woo Lane Playground and the temporary alteration of sections of Sai Woo Lane and Des Voeux Road West as vehicular access, as delineated and shown in yellow, red, blue and pink respectively on the Plan number WIL/G05/0002/4 during the period from 14 August 2014 to 30 January 2015 for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out, the areas of the open space and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure or alteration of the relevant part or parts of the open space and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open space and the roads affected by the Order.

Notice is hereby given that further closure and/or alteration of the same part or parts of the open space and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure and/or alteration will be published if and when such an order is made.

(a) The open space in Sai Woo Lane Playground, as delineated and shown in vellow on the Plan. The open space will be temporarily closed for the construction of the entrance of the railway station at Sai Ying Pun and the associated railway facilities of the MTR West Island Line

(b) The section of Tsz Mi Alley adjacent to Sai Woo Lane Playground, as delineated and shown in red on the Plan.

The footpath will be temporarily closed for the construction of the entrance of the railway station at Sai Ying Pun and the associated railway facilities of the MTR West Island Line.

(c) The sections of Sai Woo Lane and Des Voeux Road West, as delineated and shown in blue and pink respectively on the Plan Parts of the footpath widths will be temporarily altered as vehicular access to facilitate the construction of the station entrance of the railway station at Sai Ying Pun and the associated railway facilities of the MTR West Island Line.
