**NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF
THE OPEN SPACE IN FORBES STREET TEMPORARY PLAYGROUND,
PART OF THE OPEN SPACE IN KENNEDY TOWN PLAYGROUND,
SECTIONS OF SMITHFIELD, FORBES STREET AND THE ROAD ADJACENT
TO FORBES STREET TEMPORARY PLAYGROUND AND
KENNEDY TOWN PLAYGROUND**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 15 November 2013 (the 'Order'), authorized:-

- (I) the temporary closure of the open space in Forbes Street Temporary Playground and part of the open space in Kennedy Town Playground, as delineated and shown in yellow on the Plan numbered WIL/G02/0003/2 during the period from 11 December 2013 to 31 August 2014; and
- (II) the temporary partial closure of the section of Smithfield between a point about 15 metres north of its junction with Rock Hill Street and its junction with Pokfield Path, the section of Forbes Street between Smithfield and Cadogan Street, and the section of the road adjacent to Forbes Street Temporary Playground and Kennedy Town Playground, as delineated and shown in pink, blue and green respectively on the Plan numbered WIL/G02/0003/2 during the period from 11 December 2013 to 10 December 2014,

for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out and the areas of the open spaces and the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered WIL/G02/0003/2 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open spaces and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open spaces and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open spaces and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
