

RAILWAYS ORDINANCE (Chapter 519)
(Order under section 22(1))

MASS TRANSIT RAILWAY ('MTR')
WEST ISLAND LINE

AUTHORIZATION FOR TEMPORARY CLOSURE OF
SECTIONS OF WILMER STREET, LI SING STREET, SUTHERLAND STREET,
DES VOEUX ROAD WEST, KO SHING STREET,
A FOOTPATH BETWEEN WILMER STREET AND LI SING STREET,
WING LOK STREET, BONHAM STRAND WEST AND QUEEN STREET

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize –

- (I) the temporary partial closure of sections of Wilmer Street between Des Voeux Road West and Queen's Road West, as delineated and shown in pink on the Plan numbered WIL/G05/0007/1;
- (II) the temporary partial closure of sections of Li Sing Street, and sections of Sutherland Street between Des Voeux Road West and Ko Shing Street, as delineated and shown in orange and light blue respectively on the Plans numbered WIL/G05/0007/1 and WIL/G06/0007/1;
- (III) the temporary partial closure of sections of Des Voeux Road West between Sai Woo Lane and Connaught Road West, as delineated and shown in green on the Plans numbered WIL/G05/0007/1 and WIL/G06/0007/1;
- (IV) the temporary partial closure of a section of Ko Shing Street between Des Voeux Road West and Li Sing Street and sections of Ko Shing Street between Li Sing Street and Queen Street, as delineated and shown in dark blue and yellow respectively on the Plans numbered WIL/G05/0007/1 and WIL/G06/0007/1;
- (V) the temporary partial closure of a footpath between Wilmer Street and Li Sing Street, as delineated and shown in grey on the Plans numbered WIL/G05/0007/1 and WIL/G06/0007/1; and
- (VI) the temporary partial closure of sections of Wing Lok Street between its junction with Des Voeux Road West and a point about 110 metres south-east of the junction, sections of Bonham Strand West between its junction with Des Voeux Road West and a point about 120 metres south-east of the junction, and sections of Queen Street between Des Voeux Road West and Ko Shing Street, as delineated and shown in purple, brown and red respectively on the Plan numbered WIL/G06/0007/1,

during the period from 25 June 2010 to 24 June 2011. I further declare under section 22(1)(c) that during the period from 25 June 2010 to 24 June 2011 all public or private rights in, upon, under or over the sections of the roads as described above shall be extinguished, modified or restricted, as the case may be.
