NOTICE OF ORDER AUTHORIZING

TEMPORARY CLOSURE OF SECTIONS OF WILMER STREET, LI SING STREET,  
SUTHERLAND STREET, DES VOEUX ROAD WEST, KO SHING STREET,  
A FOOTPATH BETWEEN WILMER STREET AND LI SING STREET,  
WING LOK STREET, BONHAM STRAND WEST AND QUEEN STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 8 June 2010 (the 'Order'), authorized:—

- (I) the temporary partial closure of sections of Wilmer Street between Des Voeux Road West and Queen's Road West;
- (II) the temporary partial closure of sections of Li Sing Street, and sections of Sutherland Street between Des Voeux Road West and Ko Shing Street;
- (III) the temporary partial closure of sections of Des Voeux Road West between Sai Woo Lane and Connaught Road West;
- (IV) the temporary partial closure of a section of Ko Shing Street between Des Voeux Road West and Li Sing Street and sections of Ko Shing Street between Li Sing Street and Queen Street;
- (V) the temporary partial closure of a footpath between Wilmer Street and Li Sing Street; and
- (VI) the temporary partial closure of sections of Wing Lok Street between its junction with Des Voeux Road West and a point about 110 metres south-east of the junction, sections of Bonham Strand West between its junction with Des Voeux Road West and a point about 120 metres south-east of the junction, and sections of Queen Street between Des Voeux Road West and Ko Shing Street,

during the period from 25 June 2010 to 24 June 2011 for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out and the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered WIL/G05/0007/1 delineating and showing the sections of the roads affected by (I), (II), (III), (IV) and (V) in pink, orange and light blue, green, dark blue and yellow, and grey respectively; and the Plan numbered WIL/G06/0007/1 showing the sections of the roads affected by (II), (III), (IV), (V) and (VI) in orange and light blue, green, dark blue and yellow, grey, and purple and brown and red respectively may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the roads affected by the Order on 11 June 2010.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

<i>The roads to be affected</i>	<i>Description of the works and the manner in which the roads will be affected</i>
(a) Sections of Wilmer Street between Des Voeux Road West and Queen’s Road West, as delineated and shown in pink on the Plan numbered WIL/G05/0007/1.	Parts of the carriageway and footpath widths will be temporarily closed for the construction of the railway tunnels of the MTR West Island Line.
(b) Sections of Li Sing Street; and sections of Sutherland Street between Des Voeux Road West and Ko Shing Street, as delineated and shown in orange and light blue respectively on the Plans numbered WIL/G05/0007/1 and WIL/G06/0007/1.	Parts of the carriageway and footpath widths will be temporarily closed for the construction of the railway tunnels of the MTR West Island Line.
(c) Sections of Des Voeux Road West between Sai Woo Lane and Connaught Road West, as delineated and shown in green on the Plans numbered WIL/G05/0007/1 and WIL/G06/0007/1.	Parts of the carriageway and footpath widths will be temporarily closed for the construction of the railway tunnels of the MTR West Island Line.
(d) A section of Ko Shing Street between Des Voeux Road West and Li Sing Street, as delineated and shown in dark blue on the Plans numbered WIL/G05/0007/1 and WIL/G06/0007/1.	The carriageways and parts of the footpath widths will be temporarily closed for the construction of the railway tunnels of the MTR West Island Line.
(e) Sections of Ko Shing Street between Li Sing Street and Queen Street, as delineated and shown in yellow on the Plans numbered WIL/G05/0007/1 and WIL/G06/0007/1.	Parts of the carriageway and footpath widths will be temporarily closed for the construction of the railway tunnels of the MTR West Island Line.

*The roads to be affected*

- (f) Sections of a footpath between Wilmer Street (near Kam Chuen Building) and Li Sing Street (near Luen Wah Building), as delineated and shown in grey on the Plans numbered WIL/G05/0007/1 and WIL/G06/0007/1.
- (g) Sections of Wing Lok Street between its junction with Des Voeux Road West and a point about 110 metres south-east of the junction; sections of Bonham Strand West between its junction with Des Voeux Road West and a point about 120 metres south-east of the junction; and sections of Queen Street between Des Voeux Road West and Ko Shing Street, as delineated and shown in purple, brown and red respectively on the Plan numbered WIL/G06/0007/1.

*Description of the works and the manner in which the roads will be affected*

Parts of the footpath widths will be temporarily closed for the construction of the railway tunnels of the MTR West Island Line.

Parts of the carriageway and footpath widths will be temporarily closed for the construction of the railway tunnels of the MTR West Island Line and its connection to the existing MTR Sheung Wan Station.
