NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF THE OPEN SPACE IN MUI FONG STREET CHILDREN'S PLAYGROUND AND CENTRE STREET SITTING-OUT AREA, PARTS OF THE OPEN SPACE IN KING GEORGE V MEMORIAL PARK, HONG KONG, AND SECTIONS OF EASTERN STREET, CENTRE STREET, HIGH STREET, THIRD STREET, SECOND STREET AND FIRST STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 15 July 2011 (the 'Order'), authorized—

- (I) the temporary closure of the open space in Mui Fong Street Children's Playground and Centre Street Sitting-Out Area;
- (II) the temporary partial closure of parts of the open space in King George V Memorial Park, Hong Kong;
- (III) the temporary partial closure of sections of Eastern Street between a point about 20 metres north of its junction with Queen's Road West and Bonham Road, sections of Centre Street between First Street and Bonham Road, sections of High Street between its junction with Eastern Street and a point about 60 metres west of the junction and sections of High Street between a point 75 metres west of its junction with Eastern Street and a point about 10 metres west of its junction with Centre Street, and sections of Third Street between Eastern Street and a point about 22 metres west of its junction with Centre Street; and
- (IV) the temporary partial closure of sections of Second Street between Eastern Street and a point about 130 metres west of its junction with Centre Street, and sections of First Street between Eastern Street and a point of about 130 metres west of its junction with Centre Street.

during the period from 6 August 2011 to 5 August 2012 for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out and the areas of the open space and the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open space and roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open space and roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open space and roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

- (a) The open space in Mui Fong Street Children's Playground and Centre Street Sitting-out Area, as delineated and shown in light blue and pink respectively on the Plan numbered WIL/G05/0008/2.
- (b) Parts of the open space in King George V Memorial Park, Hong Kong, as delineated and shown in grey on the Plan numbered WIL/G05/0008/2.
- (c) Sections of Eastern Street between a point about 20 metres north of its junction with Queen's Road West and Bonham Road; sections of Centre Street between First Street and Bonham Road; sections of High Street between its junction with Eastern Street and a point about 60 metres west of the junction and sections of High Street between a point about 75 metres west of its junction with Eastern Street and a point about 10 metres west of its junction with Centre Street; and sections of Third Street between Eastern Street and a point about 22 metres west of its junction with Centre Street, as delineated and shown in brown, yellow, red and dark blue respectively on the Plan numbered WIL/G05/0008/2.

Description of the works and the manner in which the open space and the roads will be affected

Parts of the carriageway and footpath widths will be temporarily closed for the construction of the entrance of railway station at Sai Ying Pun and the associated railway facilities of the MTR West Island Line.
