NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF
THE OPEN SPACE IN SAI WOO LANE PLAYGROUND AND
A SECTION OF TSZ MI ALLEY ADJACENT TO SAI WOO LANE PLAYGROUND
AND TEMPORARY ALTERATION OF SECTIONS OF SAI WOO LANE AND
DES VOEUX ROAD WEST AS VEHICULAR ACCESS

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 20 July 2010 (the 'Order'), authorized the temporary closure of the open space in Sai Woo Lane Playground and a section of Tsz Mi Alley adjacent to Sai Woo Lane Playground and the temporary alteration of sections of Sai Woo Lane and Des Voeux Road West as vehicular access during the period from 14 August 2010 to 13 August 2011 for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out, the areas of the open space and the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered WIL/G05/0002/2 (the 'Plan'), delineating and showing the open space and the sections of the roads affected in yellow, red, blue and pink respectively, may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the open space and the roads affected by the Order on 30 July 2010.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong so as to reach the Secretary before the expiration of one year from the closure or alteration of the relevant part or parts of the open space and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open space and the roads affected by the Order.

Notice is hereby given that further closure and/or alteration of the same part or parts of the open space and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
