

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

PWP ITEM NO. 888TH
WIDENING OF YUEN LONG HIGHWAY
(SECTION BETWEEN LAM TEI AND TONG YAN SAN TSUEN)

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. 60695325/GAZ/100 to 60695325/GAZ/105 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of at-grade carriageways, elevated carriageways, a footpath, pedestrian subways, at-grade carriageways above pedestrian subways, access roads and amenity areas;
- (ii) permanent closure and conversion of sections of the existing at-grade/elevated carriageways into central medians/refuge islands;
- (iii) permanent closure and conversion of sections of the existing at-grade carriageways into verges;
- (iv) permanent closure and conversion of sections of the existing access roads, amenity areas and central medians/refuge islands into at-grade carriageways;
- (v) temporary closure and reconstruction of sections of the existing at-grade carriageways, elevated carriageways and central medians/refuge islands;
- (vi) permanent closure and conversion of sections of the future footpaths under PWP Item Nos. 7817CL and 7827CL (Part) Road Works under Yuen Long South Development Stage 1 Works and Stage 2 Works, Phase 1 ('YLS First Phase Development') into an at-grade carriageway and an amenity area;
- (vii) permanent closure and conversion of a section of the future amenity area under YLS First Phase Development into a footpath;
- (viii) temporary closure and reconstruction of sections of the future at-grade/elevated carriageways and a footpath under YLS First Phase Development;
- (ix) temporary closure and reconstruction of sections of the future at-grade/elevated carriageways under PWP Item No. 7827CL (Part) Road Works under Yuen Long South Development—Second Phase Development ('YLS Second Phase Development');
- (x) realignment of a section of the future vertical noise barrier under YLS First Phase Development;
- (xi) realignment of sections of the future cantilever noise barrier and vertical noise barrier under YLS Second Phase Development; and
- (xii) ancillary works including slope stabilization, geotechnical, drainage, sewerage, water supplies, utilities, lighting, landscaping, electrical and mechanical works, installation of street furniture, traffic aids, traffic control and surveillance system, as well as construction of vertical noise barriers, cantilever noise barriers, retaining walls and slopes.

Any person who wishes to object to the works or the use, or both, is required to address to the Secretary for Transport and Logistics an objection in writing, which can be submitted *via* one of the following means:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Any objection lodged on a ground relating to any compensation (whether monetary or non-monetary) or any financial or other assistance in connection with the works or the use is, to the extent that it is lodged on that ground, invalid and treated as not having been lodged for the purposes of section 11 of the Ordinance. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 19th day of December 2023.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to further process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
