**SPECIFIED HOURS TO ENTER TSING MA BRIDGE AREA**

Pursuant to regulation 23B(3AA)(a) of the Shipping and Port Control Regulations (Cap. 313A) and section 19(3A)(a) of the Merchant Shipping (Local Vessels)(General) Regulation (Cap. 548F), I hereby specify that –

(a) the period under regulation 23B(3AA)(a)(i) of Cap. 313A and that under section 19(3A)(a)(i) of Cap. 548F is from **6 October 2024 to 2 November 2024**, both dates inclusive (hereinafter called the ‘Period’); and

(b) in relation to each day of the Period as respectively set out in the first column of the following table, the ‘specified hours’ under regulation 23B(3AA)(a)(ii) of Cap. 313A and those under section 19(3A)(a)(ii) of Cap. 548F are to be those in the second column of the following table corresponding to that day.
