THIS DRAWING IS PREPARED BASED ON DRAWING NO. XRL-G49 (REVISION 1) AND IS INTENDED TO SHOW THE SECTIONS OF CHI HO ROAD (HIGHLIGHTED IN RED) OF WHICH PARTS OF THE CARRIAGEWAY AND FOOTPATH WIDTHS ARE TO BE TEMPORARILY CLOSED.

**一般說明 GENERAL NOTES**
